Major Agreements or Operating Assumptions Between Participants, their Families, & the Institute.

- I agree to respect the dignity, individuality, rights, and property of others. Pejorative references, unwanted affection, or other actions that may reduce the comfort, dignity, or rights of another is a serious matter. Stealing or damaging another's property is likewise serious. Racism, sexism, elitism, or any other "ism" that hurts others or their rights is deplorable and will not be tolerated.
I agree to remain on the University of Iowa campus at all time. Prior arrangements for a brief absence may be made only by the parents, custodial guardian, or legal guardian whose signature appears on the Enrollment Form and this form (requires 48 hours notice unless the legal guardian is physically present). The absence is not to interfere or conflict with Institute classes or other scheduled activities.
I agree to ride only in vehicles provided by the Institute. All transportation is provided by the University of Iowa motor pool. Students are not permitted to ride in the cars of staff members or any other person between arrival and departure except with written permission of the legal guardian.
I agree to be present in Quadrangle Hall by 10 pm, in my assigned room after 11 pm, and to turn out all lights by midnight. Students are expected to leave the library in time to be inside Quadrangle at 10 pm, where they are to remain until 6 am. At 11 pm, students are expected to make room check. Students are not to leave their rooms after 11 pm except to use the facilities or to evacuate the building in an emergency. Lights must be out by 12:00 midnight.
I agree to arrive on time to and participate actively in all scheduled institute activities. Students are excused from classes only when they have been seen by a doctor who prescribes rest. Students may not simply "lie down until they feel better." Accordingly, if students are not ill, they are expected to show up on time to whatever activity is scheduled. If students are ill, they are expected to contact the medical liaison immediately.
I agree to be orderly in the University libraries, classroom, and other facilities. The destruction of library materials or other University property is very serious. Destruction of library materials is construed to mean, among other things, writing in books, tearing out pages, or reducing the life of a book, journal, or periodical through means other than ordinary use.
I agree to remain free of alcohol, tobacco, or other unprescribed substances. It is illegal for a minor to purchase, possess, or consume alcohol or tobacco in Iowa. It is a violation of this agreement for a student to take any unprescribed medication including caffeine pills such as "No Doze," etc. Obviously, drugs such as marijuana are illegal for everyone.
I agree that if I fail to follow the policies and direction of the Institute, my parents will be notified and I will be sent home at my parents' sole expense.

I have studied each of the eight statements of this agreement, and by my signature, I indicate that I understand and pledge compliance with each during the time I am at the Institute.
